1. Candidates will submit their initial applications online using the username and password they created through the [Application System](#).
2. During the initial online application, it is mandatory to upload the originals and Turkish translations of your **diploma/graduation** certificate and **transcript** to the system. Additionally, a valid passport (blue card holders may submit their blue card instead of a passport) or a valid residence/work permit document issued in Türkiye must also be uploaded to the system. **Documents must be legible and of high resolution.** Documents that are unclear to the point of being incomprehensible **will not be considered under any circumstances.** **All responsibility** for any loss of rights resulting from incomplete or incorrect information (scores, documents, etc.) lies with the applicant.
3. In cases where the candidates' graduation certificates do not include their grade point average on a 100-point scale, the grade corresponding to their graduation will be used in the application and evaluation process according to the '[Equivalents of Grades on a 4-point Scale to Grades on a 100-point Scale](#)' table of the Council of Higher Education (YÖK).
4. All applicants must obtain detailed information from the current '[Application and Student Admission Guidelines](#)' and '[Application and Student Admission Guidelines Appendix-1 \(Programmes for which Applications can be Made Based on Graduation\)](#)' at <http://lee.dpu.edu.tr>, which are the basis for application conditions and evaluations.

DOCUMENTS REQUIRED FOR FINAL REGISTRATION

- 1) Postgraduate Registration Form (the form must be completed, printed, signed and submitted),
- 2) Three (3) passport photos taken within the last six months,
- 3) A notarized copy of a passport/blue card with a valid visa covering the final registration dates announced by our institute (11–20 August 2025) or a photocopy of the original residence/work permit document in Türkiye. Applicants from countries exempt from visa requirements must not have exceeded the stay period specified by law,
- 4) For applicants who have completed their undergraduate or graduate education outside of Türkiye and the Turkish Republic of Northern Cyprus (equivalency granted by YÖK), a certified copy of their diploma/graduation and transcript documents translated into Turkish by a notary public affiliated with the Turkish Ministry of Justice,
- 5) A certified copy of the diploma/graduation and transcript documents of candidates who have completed their undergraduate or graduate education at higher education institutions in Türkiye and the TRNC (recognized by the Council of Higher Education)
- 6) Candidates who have completed their secondary education outside of higher education institutions in Türkiye and the TRNC (recognized by YÖK) must submit a YÖK equivalence/school recognition certificate and a photocopy thereof,
- 7) If applicable, a document proving language proficiency in the language of the postgraduate program,
- 8) Candidates who have been granted the right to enroll in programs taught in Turkish must take the e-YTDS or Yunus Emre Institute Turkish Language Proficiency Test (YTDS) administered by the Measurement, Selection and Placement Centre (ÖSYM) within the last two years and obtain a minimum C1 level in Turkish. Measurement, Selection and Placement Centre (ÖSYM) e-YTDS or Yunus Emre Institutes within the last 2 (two) years. Candidates who have these documents can register for postgraduate education courses
- 9) Candidates who have been granted admission to programs taught in Turkish must take the Turkish proficiency (exemption) / Turkish level determination exam organized by the Turkish Language Teaching Application and Research Centre (TÖMER) Directorate of Kütahya Dumlupınar University and obtain a minimum C1 level Turkish proficiency score.
- 10) Language requirements for students graduating from Turkish programs.
 - a) Foreign nationals who have graduated from a Turkish language program at a higher education institution in Türkiye **are not required to meet the Turkish language requirement.**
 - b) **No Turkish language requirement is sought for applications** made to departments where the program language is not Turkish.
 - c) Foreign nationals who have graduated from a higher education program offering Turkish language education abroad must take the Turkish language proficiency exam organized by Kütahya Dumlupınar University TÖMER and obtain a **minimum C1 level Turkish language proficiency score.**
 - d) Foreign applicants who have been granted the right to enroll in programs taught in a language other than

Turkish must have obtained a score of 55/100 in the ÜDS/KPDS/YDS/e-YDS/YÖKDİL 55/100 points or a score of 60/100 points in the proficiency exam administered by the School of Foreign Languages at Kütahya Dumlupınar University.

e) If applicants do not have a document proving their language proficiency, they are required to meet the language proficiency requirement within 2 (two) years from the date of final registration. **This period is not taken into account** when calculating the maximum period. Students who fail to meet the language proficiency requirement within the specified period **will have their registration cancelled**.

Students who meet the above language requirement may begin taking courses in graduate programs.

- 11) Health reports from state or university hospitals affiliated with the Turkish Ministry of Health stating that the person does not have tuberculosis and, based on the results of comprehensive blood tests conducted by the infectious diseases unit of the hospitals, does not have any other infectious diseases
- 12) A document proving that the student is receiving a scholarship (for students receiving a state scholarship, an official letter from the relevant state institutions, country embassies or official institutions stating that their fees will be paid)

Applicants from countries exempt from visa requirements must not have exceeded the stay period specified by law,
- 4) For applicants who have completed their undergraduate or graduate education outside of Türkiye and the Turkish Republic of Northern Cyprus (equivalency granted by YÖK), a certified copy of their diploma/graduation and transcript documents translated into Turkish by a notary public affiliated with the Turkish Ministry of Justice,
- 5) A certified copy of the diploma/graduation and transcript documents of candidates who have completed their undergraduate or graduate education at higher education institutions in Türkiye and the TRNC (recognized by the Council of Higher Education)

 - c) Foreign nationals who have graduated from a higher education program offering Turkish language education abroad must take the Turkish language proficiency exam organized by Kütahya Dumlupınar University TÖMER and obtain a **minimum C1 level Turkish language proficiency score.**
 - d) Foreign applicants who have been granted the right to enroll in programs taught in a language other than

Turkish must have obtained a score of 55/100 in the ÜDS/KPDS/YDS/e-YDS/YÖKDİL 55/100 points or a score of 60/100 points in the proficiency exam administered by the School of Foreign Languages at Kütahya Dumlupınar University.
