



INTERNATIONALIZATION STRATEGY OF KUTAHYA DÜMLUPINAR UNIVERSITY INTERNATIONAL RELATIONS OFFICE

Kütahya Dumlupınar University (DPU) is a young university that was founded in 1992. In addition to this, by developing quickly in a short time, today DPU takes place in the first ten percent of the Academic Ranking of World Universities. It has a dynamic academic staff that was educated in the prestigious universities of our country and world. With its architecture and design, it has one of the richest and most beautiful campuses in Türkiye. Kütahya Dumlupınar University has a vision of highly qualitative education, scientific and technological productivity, social and cultural contribution, cooperation of university and industry and taking part in international academic world. It undertakes the mission of making its students skillful enough to build a career and work in each country of the world, being integrated with the world for scientific development and innovation, contributing to the social and economic fields within the scale of regional and global, and making up prescriptions. The priority areas of DPU are boron and mining, biotechnology, ceramics, underground sources, which are key elements for initiative of bilateral cooperations with countries in the world. It is believed that exchange of ideas and joint projects regarding those subjects widens the perspective of both academic staff and students in the competitive areas, and also makes a great contribution to the academic development of the young generation. With the advantage of partnership opportunities with non-EU countries from the regions of Western Balkans, Neighbourhood East, South-Mediterranean, Russian Federation, Asia, Central Asia, Sub-Saharan Africa, Latin America, Canada Kütahya Dumlupınar University has undertaken the mission to cooperate with higher education institutions of the countries in these regions and transfer the positive side of European Education system to these universities and also to expand the mobility areas for new horizons for new possible scientific dimensions. With such cooperations, it will be possible to remove the borders out of Europe, contributing to the educational developments not only in Europe but also all the world and also through such partnerships will help the nations to destroy prejudices to each other and thus scientific relationships will be in a continuous progress via mobility opportunities ensured by Erasmus+ Exchange Program for student and staff. In this

process DPU's good relationship with partners from non-EU countries within the scope of Mevlana Exchange Program which is conducted by Turkish Council of Higher Education, will contribute to the development of Erasmus Partnership Opportunities with that institutions. Among non-EU countries, the region of Latin America has been one of the target destinations where Kütahya Dumlupınar University has some agreements and cooperations with some higher education institutions. As a consequence of bilateral contacts, Kütahya Dumlupınar University has founded powerful relations with the higher education institutions from Argentina and Columbia. Being aware of the importance of internationalization not only from Europe or Asia but also transoceanic countries, Kütahya Dumlupınar University has a cooperation with National University of Quilmes in Argentina within the framework a project funded by Argentina Ministry of Education to extend the area of cooperation between Argentina and Türkiye. In addition, DPU aims to have Erasmus+ agreements within the scope of Erasmus+ Partner Countries both for student and staff mobility within 2 years of time. With the University of Magdalena in Columbia, there exists a Mevlana Protocol, too. DPU gives high importance to international agreements since it is considered as cooperation with EU and non-EU countries means to world-wide internalization. For that reason, DPU is open to new cooperations with different countries. As a result of some personal contacts, DPU has cooperated with Ukraine which is a partner country neighbouring to EU. To enhance knowledge in both national and local levels, Kütahya Dumlupınar University signed bilateral agreements with Zhytomyr State Technological University and National Technical University of Ukraine—"Igor Sikorsky Kyiv Polytechnic Institute. With the purpose of building up relations to Erasmus+, KA107 agreement was signed between Zhytomyr State Technological University and Kütahya Dumlupınar University for the department of Mining Engineering within the scope of International Credit Mobility Programme. These relations are strengthened via academic visits of university representatives. Development Cooperation Instruments (DCI) is the EU's major financial instrument for development cooperation in the 2014-2020 period. Given the importance of higher education for economic and social development, the Erasmus+ programme supports partner countries in meeting the challenges in their higher education systems. Bangladesh is in the group of Asia 6 under the DCI scholarships. Daffodil University is one of the best private universities in Bangladesh. The mission of the university is to pursue quality education and research of international distinction for the benefit of human society. With regard to the similarity between the strategies of Kütahya Dumlupınar University and Daffodil University, cooperation between the institutions began in EAIE Fair/Scotland on 15-18 September, 2015, in which organization representative of DPU met Mr. Md. Sabur Khan, head of Board of Trustees

of Daffodil University. Since October 2015, cooperation between Higher Education Institutions has been proceeding regarding the engineering departments. Erasmus+ ICM will also make a great contribution for this cooperation. Within the international dimension of the Erasmus+ Program, the European Union offers grants for both students and staff in Australia, Japan, India and the U.S.A., which are ahead of the other countries in the World in terms of technology. As DPU, it aims to foster institutional engagement with universities to seek partnerships and collaborations and to enhance research, teaching and learning, and community engagement, through participation in workshops, symposia and conferences and trainings. DPU and Yamaguchi University (Japan) are partner institutions within the scope of the Mevlana Exchange Programme based on the Project. Also, archaeological site excavations were organized with the cooperation of the University at Buffalo (the U.S.A.). Besides, academic staff relations between universities in Australia have continued for a long time. Along with having a special place in the history of the relations between the two countries in the Battles of Çanakkale, and encountering Turkish and ANZAC troops, these academic sorts of relations between countries will come much closer to each other. Türkiye has a deep root with Maghreb Countries such as Morocco, Algeria, Tunisia and Libya during the history. Based on that relation, DPU has begun initiatives for those countries since its foundation. Many academicians and experts participated in the conference and symposium organized by DPU in summer, of 2016. Apart from those relations, bilateral agreements within the Mevlana Exchange Programme and MoUs have also been signed in order to provide mobilities of students and staff. DPU intends to enlarge the cooperation with Maghreb Countries via Erasmus+ ICM in order to contribute to the personal development and employability of students. Besides, it prompts universities to develop better services to send and receive foreign students, compare and upgrade curricula, improve teaching and strengthen their institutional leadership and management to gain international visibility. DPU is in close contact with universities in Maghreb countries within the Mevlana Exchange Programme, too. It is aimed to provide Bologna Process and ECTS adaptation and increase the quality of the education system for those universities. DPU has also taken part in two consortiums both of which consist of the region's universities. Thanks to these consortiums, universities will send students abroad for internships which will improve the university's relationship and connection with industrial companies and the business world. This opportunity will also prepare the students for real life and their future careers by opening up their horizons. Also, DPU's partnership with local industries of which our university makes announcements, attracts students from abroad to do their internships in Türkiye.

Kütahya Dumlupınar University (DPU) is an institution that has taken increasing and

developing international collaborations among its priorities in its internationalization strategy with the vision of being a nationally and internationally preferred, entrepreneurial and innovative university. With this strategy, it's aimed to establish cultural and scientific partnerships with institutions from different geographies. DPU, which has been successfully carrying out Erasmus+ KA171 activities since 2016, wants to continue these movements. In this context, to transfer our experience to non-European countries and to meet the European standard in higher education to spread it, It wants to continue its academic activities with institutions located in 9 different regions: Western Balkans (Albania, Bosnia-Herzegovina, Kosovo, Montenegro), Neighbourhood East (Georgia, Moldova, Ukraine, Azerbaijan, Belarus), South-Mediterranean countries (Algeria, Morocco, Jordan, Palestine, Tunisia, Lebanon), Russian Federation, Asia (Japan, Indonesia, China, Malaysia, Taiwan, Thailand), Central Asia (Uzbekistan, Kazakhstan, Kyrgyzstan), Sub-Saharan Africa (Kenya, Somalia, Niger, Tanzania), Latin America (Argentina and Brazil), USA and Canada. Each year, it also tries to expand its boundaries through the Capacity Building Project for Higher Education Projects. DPU Engineering Faculty is the leader in designing those projects, the experienced project team has been coordinating 4 CBHE projects.
